FROM THE CLUB BY-LAWS

PART 2 - MEMBERSHIP

- (f) **JUNIOR MEMBER** – a person from age eight years to eighteen years inclusive residing within the area prescribed for regular members, who has paid the prescribed fee, followed the prescribed procedure of sponsorship and responsibility and has been accepted by the Executive committee. A Junior member shall be entitled to all the privileges of the Club but shall not vote or hold office, and shall have no interest in any property of the club. Upon reaching the age of nineteen years a Junior member may become a regular member if the prescribed conditions are met. A Junior member shall not earn moorage seniority.

FROM CLUB RULES AND REGULATIONS

2. Any member shall cease to be a member of the Club pursuant to By-Law 7(d) if he fails to pay any amount owed by him to the Club for forty-five (45) days after it became payable.
